- Aug. 2 Take an authentic sternwheeler Riverboat cruise and learn about the history of Fairbanks. Lunch at the Riverboat Landing. In the afternoon take a Gold Mine Tour. Evening is on your own to enjoy Alaska's Golden Heart City.
- Aug. 3 Enjoy a scenic motorcoach journey to Denali National Park and the Denali Princess Wilderness Lodge - your home for the next 2 nights. The rest of the day is at your leisure to enjoy! Many optional excursions are available.
